




LAST MEETING UPDATES

- The budget expired in 2022
 - Dec of 2022 the life of the TIF till was extended until 2034.
- 2025 there has not been any budget that has passed and therefore the city is **not** able to use any money from the current Pilsen Industrial TIF
- No money has been spent since 2023. All projects must get passed via the Committee on Finance and pass in city council. **Anything that passed in 2022 would have been funded before the budget expiration (Dec. 2022).**
 - **The Pilsen Industrial TIF generates an estimated \$30mil a year. Since 2023 money generated by the current TIF is locked and cannot be used until a budget is passed**
