## KNOW YOUR RIGHTS WHEN INTERACTING WITH IMMIGRATION OFFICERS (ICE)

- If you believe you are witnessing ICE activity, please call ICIRR's 24-Hour Family Support Hotline at 1-855-HELP-MY-FAMILY (1-855-435-7693).
- If you find yourself interacting with an ICE officer in any location including your workplace, or out in the community, remember:
  - You have the right to remain silent when questioned or arrested by immigration officers
  - You should remain calm and keep your hands where the officer can see them.
  - You can state that you wish to speak with an attorney.
  - You are not required to
    - Discuss your immigration or citizenship status with the police, immigration agents, or other officials
    - Sign anything you do not understand.
- If an officer knocks on your door at home:
  - You have the right to not open the door.
  - ICE officers must have a **warrant signed by a judge** to enter your home. ICE "warrants" are not signed by judges; they are ICE forms signed by ICE officers and they do not grant authority to enter your home without your consent
- If you are outdoors and think you see immigration officers nearby:
  - You can move to a safe indoor space
  - If you are a U.S. citizen and feel safe to do so, you can record the activity with your phone or write down any relevant information about what you witness—**ALWAYS** being careful to not interfere or otherwise obstruct the operation
  - **DO NOT:**
    - Post unverified information on social media
    - Interfere with the investigation or otherwise put yourself in harm's way

## KNOW YOUR RIGHTS WHEN INTERACTING WITH IMMIGRATION OFFICERS (ICE)

Establish a **safety plan** that your family can use if ICE arrests you. Key parts of a safety plan include:

- Identify your emergency contacts and memorize their phone numbers.
- Provide your child's school or daycare with an emergency contact to pick up your child.
- Provide authorization in writing for your emergency contact to make medical and legal decisions for your child.
- Tell your loved ones that if you are detained by ICE, they can try to use ICE's online detainee locator to find you: [locator.ice.dhs.gov](http://locator.ice.dhs.gov)
- Carry your valid immigration documents. If you do not have such documents, carry copies of documents that show that you have been in the US for at least two years (if that is the case). Examples include housing, employment, or education records
- If you are detained, it is important that you seek legal representation.

## Community Development Grants (CDG) – Apply by Feb. 13, 2026

CDG grants cover eligible new construction and renovation through proceeds from the 2024 Housing and Economic Development Bond and other funding sources. CDGs are available at three funding levels to support local commercial and light manufacturing projects via Small (up to \$250,000), Medium (\$300,000 - \$5 million) and Large grants (\$5 million and up).



## Cook County Spay and Neuter Rebate Program

Cook County's Animal and Rabies Control Spay and Neuter Program is held each February and provides a rebate to animal hospitals and clinics for any spay or neuter services provided in that month to Cook County residents.

### Eligibility

This program is conducted during the month of February only

Only Cook County residents are eligible

Must present proof of Cook County residency at the time of drop-off (ex: drivers license or utility bill)

### Rebate Amount

Rebates are one amount:  
\$40.00\* for each animal whether they are being spayed or neutered.

Additional fees may apply.  
Brachycephalic dogs require a pre-surgical exam, bloodwork, and take-home medication, and a \$200 spay/neuter fee applies.  
Exotic cats require a pre-surgical exam, bloodwork, and proBNP test.

All pets participating in the program must be up-to-date on their rabies vaccine and have a current Cook County rabies tag. Vaccination the day of surgery is permitted.

- If vaccination has been done previously in another county, state or country and is current, we may issue a Cook County rabies tag only if the vaccination was on or after January 1, 2026. If the vaccination was given prior to December 31, 2025, you must obtain a rabies tag from Cook County Animal Control. Please bring your rabies certificate with you at the time of check-in!


